During the COVID-19 pandemic, the delivery of remote learning necessitates innovative and alternative means for providing instruction to students who are engaging in learning from home. During the 20-21 School Year, Lockport District 91 will utilize live streamed and recorded instruction for students. This delivery of group and classroom services poses unique confidentiality considerations for children and their families:

- 1. I acknowledge that during the COVID-19 pandemic circumstances, the Illinois State Board of Education (ISBE) has given parents the opportunity to choose between blended learning and full time remote instruction for their children. I also acknowledge that the ISBE is recommending that students engaging in remote learning (whether continuously or through the blended learning option) receive synchronous, or live streamed classroom instruction. I understand that Milne-Kelvin Grove District 91, consistent with ISBE recommendations, will live stream classroom instruction for those students learning from home.
- 2. I understand that the classroom instruction is being live streamed and the camera will primarily focus on the classroom teacher. I understand that non instructional time in the classroom will not be live streamed. I acknowledge, however, that the District cannot guarantee that my child's image or voice will never be captured in the video. Furthermore, there may be occasions where the teacher may not be seen in the frame.
- 3. I understand that the live stream video will be made available only to students who are members of the classroom. I also understand that the video will not be maintained as a record by the District and that it will be deleted. I acknowledge that though it is discouraged, the District cannot guarantee that occupants in the homes of children receiving remote instruction will refrain from listening to or observing the live stream video. I agree that I will not record, download, host, stream, or share content posted in the digital classroom or broadcast via live stream.

I understand that my child's teacher will not disclose personally identifiable information* about my child during live stream videoing, will instruct and caution students in the classroom not to disclose personal information, and may stop the live stream video if there is a situation in the classroom that is not appropriate for live stream viewing. I acknowledge, however, that the District cannot guarantee that personally identifiable information about my child will never be inadvertently shared. *Personally identifiable information for education records is a FERPA term referring to identifiable information that is maintained in education records and includes direct identifiers, such as a student's name or identification number, indirect identifiers, such as a student's date of birth, or other information which can be used to distinguish or trace an individual's identity either directly or indirectly through linkages with other information. This does not include a student's first name, phone number, or other directory information.
- 5. I understand that all District policies applicable to technology will continue to apply.
- 6. I understand that my refusal to sign this Consent may limit my child's access to digital resources required for blended and remote instruction.
